

Outright Gifts

Donate cash, stocks & mutual funds, and IRA distributions, including required minimum distributions and qualified charitable donations.

Name Endowment

With a gift of \$100,000 you may create a Named Endowment. Additional gifts to said endowment may be made at any time. An endowment gives you peace of mind by providing an annual distribution to assist your church in continuing its mission and ministry into the future.

Donor Advised Fund

A Donor Advised Fund is a Named Endowment that allows you to select the recipients of the annual distribution each year.

Unrestricted Fund/Next Generation Fund

Donations made to these funds may be used for any mission seeking funding. The Next Generation Fund may not be used until the year 2030.

Bequest in Will

Name your church or favorite ministry as a beneficiary in your will.

Life Insurance Gift

IRA

Consider making a donation from your IRA Minimum Required Distribution.

Charitable Remainder Trust

Charitable Remainder Trusts provide you with semi-annual payments now. Remaining funds could be distributed to the CUMC Foundation, according to the language in your trust documents.

Charitable Gift Annuity

A Gift Annuity will provide you with fixed payments during your lifetime with the remainder of the gift going to the church or ministry of your choice.

The CUMC Foundation partners with the Dakotas/Minnesota Foundation and Wespath for fund management & disbursements. These partners ensure responsible stewardship and timely processing of gifts
